Package A

- Tee Reservations can be made up to 6 days in advance
- One nominated person per card can have handicap and competition privileges
- One 24 player, 18 hole outing/golf day is included with each card additional players can be included at discounted fees – catering to be charged as required
- Outing/ golf day can be booked Monday to Friday with final tee time no later than 3.45pm
- Use of Clubhouse for non-golf events October March, subject to availability

Voucher scheme

Payable in one payment before issue
